Applications must be submitted online via the **UK Government's official passport website**, and supporting documents can be sent via courier to HM Passport Office in the UK. In some cases, applications can be submitted through the British Embassy in Rome, but this is limited to emergency situations.

Emergency Travel Documents (ETDs)

If a British national in Italy loses their passport and needs to travel urgently, an **Emergency Travel Document (ETD)** can be issued by the British Embassy in Rome. We assist clients in:

Preparing the necessary documentation for an ETD application.

Certifying documents required for the application.

Advising on travel restrictions associated with an ETD.

Legalisation and Apostille of Documents

For applicants born outside the UK or with documents issued in Italy, legalisation may be required. We assist in:

Ensuring documents meet the requirements of the Hague Apostille Convention (1961).

Advising on any additional authentication required by HM Passport Office.
